5.VILLAGE HALL UPDATE

Cllr Cleugh reported that Hutton Builders had been engaged to carry out the work required to demolish and rebuild the Village Hall. An asbestos survey has been completed and a small amount of asbestos will need to be removed by licenced contractors. Once this is dealt with demolition work will begin.

The contents of the village hall will be moved to a local farm where it is to be stored in a barn until the new hall is finished.

TVBC Councillor Maureen Flood confirmed TVBC are funding projects which can help with the current cost of living crisis. There are also grants available to organisations for such things as warm hubs. The vaccination hub in the Chantry Centre has now reopened as a health hub which is collectively run by all the Andover Drs Practices.
